What follows are notes of the presentations and conversation associated with each session.

I. Introductions

- Everyone introduced themselves by name, neighborhood, and institutional/associational group affiliation (as a way of reinforcing our neighborhood-based and cross-scale/cross-sector orientation).
- Data Stewards were asked to fill out the sign-in sheet, adding their home and work addresses, so that the Collaborative can create a map illustrating geographically the network that is the Community Data Collaborative.

II. Datasets: What we've got so far for the online community platform

- The Urban Institute has created a neighborhood-centric version of the Community Platform based on the specifications our community provided.
- Data stewards examined the map of Sarasota County neighborhoods identified so far; which will be used in the Community Platform.
- Data stewards thoroughly reviewed the datasets to be included in the Community Platform.
- Urban Institute will transfer all census data available at the block-scale that relates to age-cohorts (both number and percentage of population for all census data.
- Suggested addition: Mobility data -- how often are people moving in/out of neighborhood? This is available through the American Community Survey
- City of Sarasota has a Flickr account, where anyone can upload photos of the City.
 Maybe this could be incorporated.
- Examples of good social stuff we could measure as a community: hope, optimism, community attachment, number of neighbors smiling out and about in the neighborhood. We will not be including these yet because they are not currently collected locally.
- City of Sarasota geocodes all members of Robert L. Taylor Centers, and updates this
 dataset every quarter. Maybe we could include that by neighborhood in the community
 platform.
- Proposed additions to Civic domain:
 - Of total # of people 18 and older, registered voters out of total
 - Members of volunteer organizations? Could ask the Giving Partner
 - Voting frequency
- Proposed additions to Health domain:
 - o Number of people covered by health insurance
 - Grocery stores
- Proposed additions to Economic domain:
 - o Tapestry data from ESRI
 - Community expenditure data
 - Measure of social dollars
 - o Earned income tax credit

- Use property appraiser's data to get home values
- Proposed DELETIONS in Natural Environment domain:
 - Scrub Jay Data- more distorting than illuminating. Should take this out of the platform
- Proposed additions in Built Environment domain:
 - Property appraiser
- Proposed additions in Transportation or Built Environment:
 - o Conditions of roads layer
- Proposed additions to "What have we got?" (Assets)
 - o fire stations layer
- Proposed additions to "What's Going on Around Here?"
 - o Events from County and Cities' Calendars
 - o Meals on Wheels recipients
 - Social service agencies that make home visits

A. Comments/Questions from Data Stewards about the Datasets for the Online Community Platform:

- What if someone is not in an identified neighborhood?
 - Users will be able to draw their own polygon, but so far it is unclear whether the platform will be able to aggregate by that polygon.
 - Because the purpose of this tool is to create a space for people to be thinking in terms of neighborhoods, we decided as a Collaborative at an earlier meeting that we will not aggregate data by census block groups.
 - Subdivisions aren't necessarily meaningful socially, in terms of how people think about their neighborhoods.
 - o Property Appraiser's database has neighborhoods assigned to each parcel
 - Uses a different methodology, and might not be updated frequently let's look into this to find out more.
- Census data is only updated once per decade and can become outdated fairly quickly, so we might want to consider another source.
 - We might be able to use ESRI business analyst to generate these neighborhood reports that are a lot more current, with forecasts every year
 - Sarasota County Government will check with their licensing representative
- How do these datasets get updated?
 - At first it will probably be one person uploading, but the goal is eventually to have automatic feeds.
- When you pull up your page, could it have a basic profile of the neighborhood?

III. Platforms and Technologies: Preparing for Platform Comparisons

 Data Stewards examined a spreadsheet of online data platforms developed by other communities around the country.

- We want to look at what is going on around the country so that we can decide as a
 Collaborative if we want to continue to invest in developing a platform with the Urban
 Institute, or if we want to invest in something else: the wisdom of this crowd will inform the
 decision that is to be made.
- Many communities listed in the document are members of OIC Weave, the Community Indicators Consortium, and National Neighborhood Indicators Partnership.
- Questions to consider when reviewing the spreadsheet:
 - Some of the platforms incorporate neighborhoods as the smallest geography those are especially worth checking out.
 - O Who is hosting the platform?
